1. Meeting called to order

The meeting was called to order at 2:12pm and a prayer was offered.

2. Confirmation of Previous Minutes

The minutes of the meeting of 16 December 2015 were approved.

3. Matters Arising from the Previous Minutes

a. SPL (Am) Bill and SPL (Regulations)

The Commissions Secretariat has now received a response from the Honourable Attorney General to the queries raised by the Commission relating to changes to the SPL (Am) Bill and were provided with those responses. In addition, Members received a finalised draft of the proposed Standards in Public Life (Amendment) Bill, 2016 which is in the process of being submitted to Cabinet for approval. The Commission continues to have concerns regarding several of the proposed amendments and thus the draft response to the Honourable Premier was redrafted to include those concerns.

b. Procurement Legislation

The Secretariat informed Members that the Procurement Team was in the process of reviewing the questions/concerns submitted on the Commission's behalf and will shortly be providing a response. Following the receipt of such a response the Commission will again consider the matter.

4. New Business

a. Tenth Report of the Commission

The Chairman has been provided with the first draft of the Tenth Report of the Commission covering the period of work from 1 August 2015 – 31 January 2016. Following her review of the Report it will be circulated to all members for input.

Second Annual Commonwealth Caribbean Association of Integrity Commissions & Anti-Corruption Bodies Conference

The Chairman has confirmed her attendance at the Second Annual Conference to be held in Trinidad and Tobago from 29 February to 4 March 2016. Although on this occasion the invitation was extended to two members of the Commission, at this time no other member of the Commission is able to attend with the Chairman due to their work schedules, however this will be confirmed within the next day.

5. Any Other Business

a. Meeting with the Leader of the Opposition

As was agreed at the last meeting, the Secretariat would not be following up further with this invitation. It was confirmed by the Secretariat, however, that no response to the earlier invitations has been received. It was agreed that the Secretariat would now extend the invitation to other Members of the Legislative Assembly on a district by district basis. Meetings will be arranged once per month until concluded.

b. Public Awareness and Public Education Opportunities

Members again discussed possible public awareness and public education opportunities which the Commission could participate in during 2016. Opportunities such as an improved website, as well as appearances by Members in the media, schools and community organisations were discussed.
