### 1. Meeting called to order

# 3. Outstanding Business

#### a. Review of Draft #2 of the SPL Bill 2010

On the 23 November 2010, the Commission received the second draft of the SPL Bill previously requested from Mr. Simamba. The CSPL discussed the draft in detail and made amendments as appropriate. The amendments will be forwarded to the Legal Drafting Department and a final meeting will then be held between the Commission Chairman and the Legal Drafting Department.

## b. CSPL Policy and Procedures Manual

The Commission discussed the current draft of the policy and procedures manual and agreed that any portions requiring amendment would be addressed following the receipt of the final draft of the SPL Bill as it remains pertinent that the relevant sections work in tandem with the new legislation.

## c. CTC Appointment procedures

- As requested in the last meeting, Mr. Ronnie Dunn, Chair of the CTC was contacted for copies of any i. terms of reference/written policies used for the appointment of members to the CTC. Mr. Dunn stated that the appointment of the CTC is prescribed under section 41 (2) of the Financial Regulations (2008 Revision) of which he provided a copy.
- The regulations state that any and all tenders submitted with a value of \$250,000 or more must be ii. evaluated by a Central Tenders Committee comprising of "the chief officer of the portfolio (or his nominee) as chairman; and such other persons as may be appointed, from time to time, by the Financial Secretary". In light of these limited requirements the Commission believes that specific qualifications required by members (i.e. specialized professional aptitudes that pertain to and facilitate effective evaluation of public tenders) should be implemented.

iii. Copies of Mr. Dunn's correspondence and section 41 (2) of the Financial Regulations (2008 Revision) will be forwarded to all members for their records.

#### 4. New Business

## a. CSPL Training Opportunities

- a. The Secretariat updated the Commission as previously requested to their alternatives for training which includes: a workshop with Professor Jeffrey Jowell (based on his availability); Miss Nicola Williams (Complaints Commissioner); or Mr. Alastair Swarbrick (Auditor General). Each session could address different needs of the Commission.
- b. An alternative option would be to receive guidance and/or training from a representative of the Trinidad and Tobago Transparency Institute. The Commission however recognized that it will need to know the full scope of its powers conferred upon by the draft SPL legislation before committing to considering this opportunity.
